John Croze Memorial Scholarship Fund Established

When John M. Croze passed away in early 2014 it was clear to see how many lives he touched in the Ishpeming community. A teacher at Ishpeming High School for 35 years, a football coach for 15 years, and a family man, he touched the lives of many. When his family chose to set up a scholarship fund with the



Marquette County Community Foundation, those people whose lives he touched showed up in droves to provide gifts honoring his memory. Nearly 300 gifts, raising over \$10,000 for the John Croze Scholarship fund have been received by the foundation to date. John's passion for math, his enthusiasm for football and other sports, and his genuine support for others, particularly his students, will never be forgotten. Thanks to so many generous donors, his memory will live on and future students will benefit from these gifts through scholarship assistance for years to come.

GIACF Provides Funds to IHS Geometry in Construction Program

The Greater Ishpeming Area Community Fund approved grant for \$1,500 to the Ishpeming High School Geometry Construction Program in the fall of 2014. Geometry



Construction applies the concepts of mathematics in an applied, hands-on, real world setting, which results in higher math achievement by students. Funds were utilized to purchase individual student whiteboards, calculators, an LCD projector and a large portable whiteboard, all materials to be utilized in the 2 classrooms that are used for this unique program. Enrollment in the program doubled in its second year and academic achievement continues to exceed expectations.

Westwood High School's Severe Cognitive Impairment Program receives support from GIACF

A grant of \$1,000 was provided to purchase a color printer and projector for Westwood High School's Severe Cognitive Impairment Program. When resources were not available in the district's budget, Special Education Teacher Mandy Moebius reached out to the Ishpeming Area Community fund for assistance. The use of printed color visuals in her classroom greatly impacted students' learning and increased their independence.
