West End Gearbusters receive funds to build robot



FIRST Robotics Competition is an international high school robotics competition which involves teams of high school students and mentors working over a six-week period to build game-playing robots that weigh up to 120 pounds (54 kg).⁵ Robots complete tasks such as scoring balls into goals, flying discs into goals, placing inner tubes onto racks, hanging on bars, and balancing robots on balance beams. The West End Gearbusters was founded in 2010 by Douglas Elliott, a teacher in the industrial arts program at Westwood High School. To compete, students needed funds to purchase materials to

build the robot. The GIACF provided \$1,500 toward the purchase of the robot components which includes items such as thin gauge sheet aluminum, structural tubing, fasteners, drive components, electronic controllers and digital encoders.

GIACF Provides Funds to "Inspiration Zone" for two projects

The Greater Ishpeming Area Community Fund approved two separate grants for neighborhood improvement projects in Ishpeming's "Inspiration Zone." The "Zone" is a 10 block area in the city in which a citizen has been aroup working with city and



community leaders to improve infrastructure and quality of life. In the spring of 2015 \$1,070 was provided to rent a dumpster for neighborhood cleanup and in the spring of 2016, \$1,500 was provided to help fund a sidewalk replacement project. Members of the zone hope that their efforts will be replicated throughout the city as other neighborhoods see how it is possible to work together to improve neighborhoods and create a better quality of life.

8-18 Media purchases laptop with GIACF funds

Technology is an important component of any media production. The 8-18 media program, a journalism and leadership program with a mission of amplifying youth's voices through adult media, is no exception. Prior to receiving funding, up to 10 youth reporters could be found huddled around one laptop computer which made it difficult to capitalize on their enthusiasm and hindered their ability to put their thoughts into words. The additional laptop provides the work space necessary for two teams to split up and work on writing and editing, allowing the youth to be more efficient in producing their journalism. The laptop cost \$450 and the GIACF Youth Fund was able to fill this gap and provide funding for this project.
