## The Blind Groundhog - Craft Beer Fundraiser

On a cold February night, Marquette came out to celebrate winter, Groundhog's Day, and craft beer to raise funds for the Community Foundation of Marquette County. The first annual Blind Groundhog - Craft Beer Sampling, held at the Marquette Regional History Center, showcased "blind" samples of beer from Upper Peninsula Breweries and hearty appetizers from local restaurants.



The event had a casual flare, with attendees encouraged to wear their flannels and don their Stormy Kromers. Participants had the opportunity to try regional beers in three categories -- Pale Ales, Seasonal, and Brewer's Choice -- and then vote for their favorites. Samples were available from Blackrocks, The Ore Dock, and Keweenaw Brewing Company. Organizer Judy Vonck said, "With the growing popularity of craft beer in the area, we thought it would be fun to have all of the brewers at one place, so people could try them all. We celebrated their craft, and the ingenuity of the people of the U.P., while raising money that stays right here in our community."

Gail Anthony, CEO of the Community Foundation, said proceeds from the event will be used to support funding in the Marquette area. The Community Foundation also has affiliate funds for Greater Ishpeming, Negaunee, Gwinn, and Big Bay.

In 2015, The Community Foundation made grants to 92 non-profit organizations in Marquette County totaling \$693,000. All of this was made possible by the generous donations of people like you.

## Clark Lambros' Beach Park Fund

The Community Foundation is proud to announce the establishment of the Clark Lambros' Beach Park Fund. The Fund will be held by the Community Foundation and interest from the fund will be used for upkeep and enhancement to the park as deemed necessary by committee recommendation.

Clark Lambros Sr. proposed the idea of the park prior to his death in 2012, to honor his late son, Clark Lambros Jr. The elder Lambros was a local businessman and owner of Vango's Pizza and Cocktail Lounge in Marquette, as well as the life partner of current Vango's co-owner Michele Butler.

Clark Lambros' Beach Park is equipped with picnic tables, barbecues, a paved parking lot, men's, women's and family restroom/bathhouse facilities and mats to make the beach more handicap accessible.

"This is the final piece of the park," said Butler, "We are happy to partner with the Community Foundation to establish a fund so that money will be available for long-term maintenance of the park."



#### Matt Davidson Memorial Scholarship Fund Established

On March 1, 2017, the Matt Davidson Memorial Scholarship Fund, a permanent endowment, was established at the Community Foundation of Marquette County with gifts received from family and friends. This fund will be used primarily to provide scholarships to graduating senior student athletes of Republic-Michigamme Schools. Matt Davidson was a highly regarded K-12 physical education/health teacher and coach in the Republic-Michigamme School district for 16 years.

A 5-on-5 basketball tournament in honor of Matt has been held annually since the popular teacher and coach died in a single-vehicle accident on U.S. 41 in Baraga county in January of 2015. Matt coached both the boys and girls varsity programs, highlighted by his 2003 girls team winning a Class D regional championship. Davidson was also the school's boys and girls track coach. This scholarship is for students that share that same attitude of hard work, commitment, and teamwork that reflects Matt's inspiration for students to dream and believe in themselves.



## Dr. Ulrickson's legacy continues with scholarship



A new scholarship fund at the Community Foundation of Marquette County will help local students receive a college education and carry on the legacy of the late Dr. Mark Ulrickson, a Marquette ophthalmologist, Ishpeming native, and supporter of the Big Brothers Big Sisters program. The Mark Ulrickson Memorial Scholarship Fund will present \$1,000 annually to a Marquette County graduating senior who excels academically and demonstrates financial need. Preference will be given to students who have participated in the Big Brothers Big Sisters program, as well as to those who are enrolling at Northern Michigan University. Dr. Ulrickson, who passed away in October 2016, served as a

Big Brother for seven years and was also a financial supporter of the program. His children, Joy La Prade, Peter Ulrickson, Juliann Ulrickson and Valerie Aalto, along with their spouses, chose to establish the scholarship in his memory.

"Our father cared about the success and well-being of the

Marquette County community and looked for opportunities to support local children and families in need," they said. "We hope this scholarship fund will continue the work he started and make a difference in the community where he invested so much of his time, money, energy and love." Born and raised in Ishpeming, Dr. Ulrickson served in the U.S. Marine Corps before returning to Marquette to earn a biochemistry degree at Northern Michigan University. After completing medical school at Michigan State University, he served for many years as an ophthalmologist in the U.S. Navy before entering private practice and returning to Marquette.
