# City of Ishpeming Community Assessment

In September 2018, the Community Economic Development Association of Michigan (CEDAM) came to the City of Ishpeming to hold a community assessment as a pilot for the Community Foundation of Marquette County. The assessment consisted of different focus groups that engaged community members about strengths and weaknesses in their city. From the meetings, three focus areas were chosen (Housing and Blight, Recreation and Marketing) to kick start new committees and develop opportunities. Community feedback from the assessment led to possible programs to pursue, including: opening a dog park, developing a campground, restoration of historic buildings and marketing the downtown area. The next meeting will be held at 6p.m. on September 18th in the Empire Room at Bell Hospital.
