

### Community Response Fund

In March, the Community
Foundation of Marquette
County, in partnership with
United Way of Marquette
County, initiated the COVID-19



Community Response Fund in in order to address issues related to the pandemic, and to provide support to local nonprofit organizations. The committee, consisting of various community leaders, meets frequently to review grant applications and distribute funds. Community needs will be addressed in three phases: immediate needs, intermediate support for nonprofits, and a final Community Response Endowed Fund, to help provide future funding to nonprofit organizations in a crisis. The Greater Ishpeming Area Community Fund and it's Youth Fund granted \$3,000 to the Community Response Fund efforts in the area. The fund has distributed over \$45,000 to date, providing grants for various programs, including: Feeding America, for Marquette County food pantries; Partridge Creek Farms, to purchase aluminum for nose pieces in face masks; Big Brothers Big Sisters, to assist families with basic needs; Hope Free Lutheran Church, to provide meals and assistance for their food pantry program; and Great Lakes Recovery Center, to purchase personal protective equipment for staff and clients.

# Greater Ishpeming Area Fund 2020 Grants

The Greater Ishpeming Area Community Fund Committee, along with their Youth Advisory Committee met this spring to review grant applications from the Community Foundation's competitive grant cycle. This year the committees distributed \$8,650 to programs in the area. Granted organizations include: Courage Incorporated, for their summer programs; Hope Free Evangelical Lutheran Church, to purchase ingredients to prepare meals for their food pantry; Cliffs Shaft Mine Museum, to assist with start up costs to purchase Michigan made products for their gift shop; U.P. Land Conservancy, to support the completion of a trail connecting the Peshekee Headwaters Nature Preserve to Craig Lake State Park; Cancer Care, to support their patient care services; Marquette County Land Bank Authority, to plant trees in the Hematite Art Park; and the Michigamme Township DDA, to update the entrance of the library for handicap accesibility.
